Facility Where Discharge Occurs: Dane Iowa Wastewater Commission WWTF, 5745 MAHOCKER ROAD, MAZOMANIE, WISCONSIN

Receiving Water And Location: Black Earth Creek, East bank of Black Earth Creek, west of the treatment plant, approximately 50 feet downstream of the railway bridge.

Brief Facility Description: The Dane Iowa Wastewater Commission owns and operates a wastewater treatment facility that provides secondary treatment and nutrient removal to a combination of commercial and residential wastewater from the Villages of Arena, Black Earth, and Mazomanie, and the Wisconsin Heights School. The facility is designed to treat an average of 693,000 gallons per day. Treatment units include raw wastewater screening, a three-ring oxidation ditch providing secondary treatment, ammonia removal, biological phosphorus removal, final clarification, summer (May – September) ultraviolet light disinfection, and effluent post-aeration.

Proposed Modification: The permit modification is proposed to reduce the effluent PFOS/PFOA sampling frequency from 1/2 months to annual, after a review of submitted data, pursuant to s. NR 205.066, Wis. Adm. Code.

The Department has tentatively decided that the above-specified WPDES permit should be modified.

Persons wishing to comment on or object to the proposed permit action, or to request a public hearing, may write to the Department of Natural Resources at the above-named permit drafter's address. All comments or suggestions received no later than 30 days after the publication date of this public notice will be considered along with other information on file in making a final decision regarding the permit. Anyone providing comments in response to this public notice will receive a notification of the Department's final decision when the permit is issued. Where designated as a reviewable surface water discharge permit, the U.S. Environmental Protection Agency is allowed up to 90 days to submit comments or objections regarding this permit determination. If no comments are received on the proposed permit from anyone, including U.S. EPA, the permit will be issued as proposed.

The Department may schedule a public informational hearing if requested by any person and shall schedule a public informational hearing if a petition requesting a hearing is received from 5 or more persons or if response to this notice indicates significant public interest pursuant to s. 283.49, Wis. Stats. Requests for a public informational hearing shall state the following: the name and address of the person(s) requesting the hearing; the interest in the proposed permit of the person(s) requesting the hearing; the reasons for the request; and the issues proposed to be considered at the hearing.

Information on file for this permit action, including the draft permit, fact sheet and permit application, may be inspected and copied at either the above-named permit drafter's office or the above named basin engineer's office, Monday through Friday (except holidays), between 9:00 a.m. and 3:30 p.m. Please call the permit drafter or basin engineer for directions to their office location, if necessary.
