PUBLIC NOTICE OF INTENT TO REISSUE A WISCONSIN POLLUTANT DISCHARGE ELIMINATION SYSTEM (WPDES) PERMIT No.WI-0031615-10-0

Permittee: Drummond Sanitary District 1, 52555 Front Avenue, Drummond, WI, 54832

Facility Where Discharge Occurs: Drummond Sanitary District 1, 52755 Eastern Avenue, Drummond, Wisconsin

Receiving Water And Location: An unnamed wetland bog draining into an intermittent tributary to Weso Lake within the White River watershed in the Lake Superior drainage basin in Bayfield County

Brief Facility Description and Summary of Proposed Changes: Drummond Sanitary District #1 owns and operates a domestic wastewater treatment system designed to treat 40,000 gallons per day and handles an average of 10,000 gallons per day (2019-2023 data). The treatment system consists of three stabilization ponds operated one after another (in series). Within these ponds naturally occurring bacteria and organisms already present in the wastewater metabolize organic matter. Once the wastewater can meet discharge standards it is authorized to be discharged seasonally (April 1 through November 30) via an effluent distribution pipe which evenly spreads the discharge out into the unnamed wetland bog receiving water. Beyond Weso Lake the discharge does not appear to connect with other surface water in the Long Lake Branch portion of the White River watershed.

It is the Department's intention to renew the permit for another term. The proposed new permit expiration date will be June 30, 2029. Limitations and conditions which the Department believes adequately protect the receiving water are included in the proposed permit. Substantial changes from the previous permit include: [1] The effluent flow limit is no longer required. [2] An effluent variable daily maximum for ammonia is not in effect. [3] Annual monitoring for the Nitrogen Series (nitrate +nitrite, total Kjeldahl nitrogen and total nitrogen) has been added to the permit. [4] Sludge monitoring for metals, PCB and PFOA+PFOS is required once during the permit term.

Persons wishing to comment on or object to the proposed permit action, or to request a public hearing, may write to the Department of Natural Resources at the above-named permit drafter's address. All comments or suggestions received no later than 30 days after the publication date of this public notice will be considered along with other information on file in making a final decision regarding the permit. Anyone providing comments in response to this public notice will receive a notification of the Department's final decision when the permit is issued. Where designated as a reviewable surface water discharge permit, the U.S. Environmental Protection Agency is allowed up to 90 days to submit comments or objections regarding this permit determination. If no comments are received on the proposed permit from anyone, including U.S. EPA, the permit will be issued as proposed.

The Department may schedule a public informational hearing if requested by any person and shall schedule a public informational hearing if a petition requesting a hearing is received from 5 or more persons or if response to this notice indicates significant public interest pursuant to s. 283.49, Wis. Stats. Requests for a public informational hearing shall state the following: the name and address of the person(s) requesting the hearing; the interest in the proposed permit of the person(s) requesting the hearing; the reasons for the request; and the issues proposed to be considered at the hearing.

Information on file for this permit action, including the draft permit, fact sheet and permit application, may be inspected and copied at either the above-named permit drafter's office or the above named basin engineer's office, Monday through Friday (except holidays), between 9:00 a.m. and 3:30 p.m. Please call the permit drafter or basin engineer for directions to their office location, if necessary.
