PUBLIC NOTICE OF INTENT TO REISSUE A WISCONSIN POLLUTANT DISCHARGE ELIMINATION SYSTEM (WPDES) PERMIT No.WI-0020621-11-0

Permittee: Village of Ettrick , 22864 N Main St. , Ettrick, WI, 54627

Facility Where Discharge Occurs: Ettrick Wastewater Treatment Facility, 15866 West Judd Street, Ettrick, WI

Receiving Water And Location: North Fork of Beaver Creek in Beaver Creek and Lake Marinuka of Black River in Trempealeau County

Brief Facility Description and Summary of Proposed Changes: Wastewaters from the Village of Ettrick are treated at a rotating biological contact (RBC) type wastewater treatment facility with an annual average design flow of 0.063 MGD, and then discharged to the North Fork of Beaver Creek. The actual annual average flow for 2023 was 0.019 MGD. The plant consists of a primary clarifier, RBC, ferric chloride addition prior to RBC's, unit final clarifier, anaerobic sludge digester, and a chlorination/dechlorination disinfection system. The sludge generated is anaerobically digested in sludge storage tanks then hauled to be land applied on department approved sites. The facility has the ability to pump sludge to drying beds, but has not used them in recent years. Significant changes for this issuance include 1) Additional ammonia nitrogen and chlorine weekly and monthly average limits to comply with the expression of limits requirements in ss. NR 106.07 and NR 205.065(7), Wis. Adm. Codes, 2) lower effluent phosphorus interim limits associated with an approved multi-discharger variance for phosphorus (MDV) and compliance schedules to comply with s. 283.16, Wis. Stats. requirements for phosphorus, and 3) PFAS sludge sampling has been included in the WPDES permit pursuant to ss. NR 214.18(5)(b) and NR 204.06(2)(b)9., Wis. Adm. Code to quantitate risk.

The Department has tentatively decided that the above-specified WPDES permit should be reissued.

Limitations and conditions which the Department believes adequately protect the receiving water are included in the proposed permit. Land application of waste shall be done in accordance with permit conditions and applicable codes. All land application sites shall be approved prior to their use. To receive a list of approved sites, or to be notified of potential approvals, contact the above-named basin engineer.

Phosphorus Multi-Discharger Variance: The Department has determined that the permittee is eligible for a phosphorus multi-discharger variance (MDV) in accordance with s. 283.16, Wis. Stats. The MDV provides a time extension for the permittee to comply with the final water quality based effluent limits for phosphorus while contributing funds towards nonpoint pollution control projects to reduce phosphorus. Comments on this determination are requested and additional supporting documentation and data are available upon request.

Persons wishing to comment on or object to the proposed permit action, or to request a public hearing, may write to the Department of Natural Resources at the above-named permit drafter's address. All comments or suggestions received no later than 30 days after the publication date of this public notice will be considered along with other information on file in making a final decision regarding the permit. Anyone providing comments in response to this public notice will receive a notification of the Department's final decision when the permit is issued. Where designated as a reviewable surface water discharge permit, the U.S. Environmental Protection Agency is allowed up to 90 days to submit comments or objections regarding this permit determination. If no comments are received on the proposed permit from anyone, including U.S. EPA, the permit will be issued as proposed.

The Department may schedule a public informational hearing if requested by any person and shall schedule a public informational hearing if a petition requesting a hearing is received from 5 or more persons or if response to this notice indicates significant public interest pursuant to s. 283.49, Wis. Stats. Requests for a public informational hearing shall state the following: the name and address of the person(s) requesting the hearing; the interest in the proposed permit of the person(s) requesting the hearing; the reasons for the request; and the issues proposed to be considered at the hearing.

Information on file for this permit action, including the draft permit, fact sheet and permit application, may be inspected and copied at either the above-named permit drafter's office or the above named basin engineer's office, Monday through Friday (except holidays), between 9:00 a.m. and 3:30 p.m. Please call the permit drafter or basin engineer for directions to their office location, if necessary.
