PUBLIC NOTICE OF INTENT TO REISSUE A WISCONSIN POLLUTANT DISCHARGE ELIMINATION SYSTEM (WPDES) PERMIT No.WI-0050016-10-0

Permittee: GRANDE CHEESE CO BROWNSVILLE, N11689 Dairy Rd, Brownsville, WI, 53006

Facility Where Discharge Occurs: Grande Cheese Co Brownsville, N11689 Dairy Rd, Brownsville, WI 53006

Receiving Water And Location: West bank of Kummel Creek, in Brownsville, Dodge County

Brief Facility Description: Grande Cheese Company manufactures Italian cheese and processes whey at its facility located near Brownsville, Wisconsin at the corner of Hwy 49 and Dairy Road in the Town of LeRoy. The facility takes in approximately 2.7 million pounds of milk per day to produce cheese, cream, whey powder, lactose powder, and sweet whey powder. Treated process and cleaning wastewaters from this operation is discharged to Kummel Creek, with high strength wastewater, brine, and treatment sludge discharged via land application.

The Department has tentatively decided that the above-specified WPDES permit should be reissued.

Limitations and conditions which the Department believes adequately protect the receiving water are included in the proposed permit. Land application of waste shall be done in accordance with permit conditions and applicable codes. All land application sites shall be approved prior to their use. To receive a list of approved sites, or to be notified of potential approvals, contact the above-named basin engineer.

Proposed Alternative Effluent Limit for Temperature: The Department has determined that water quality-based effluent limitations (WQBELs) for temperature are needed in this permit to assure attainment and maintenance of thermal water quality standards. The WQBELs for this permittee are: Jan – 61°F, Feb – 61°F, Mar – 68°F, Apr – no limit, May – 78°F, Jun & July – no limit, Aug – 82°F, Sept – 76°F, Oct – 66°F, Nov – 57°F, Dec – 60°F. As allowed under NR 106 Subchapter VI, Wis. Adm. Code, the permittee has requested an alternative effluent limit (AEL) for temperature. In support of this request, the permittee has submitted a demonstration that the WQBELs for temperature are more stringent than necessary to assure protection and propagation of shellfish, fish and wildlife in and on the body of water into which the discharge is made. The Department concurs with the demonstration based on the information submitted and proposes to establish an AEL as follows: Jan – 66°F, Feb – 66°F, Mar – 69°F, Apr – July – no limits, Aug – 85°F, Sept – 84°F, Oct – 79°F, Nov – 73°F, Dec – 70°F. Effluent monitoring requirements are included at the frequency described in this permit. All data submitted by the permittee are available for public inspection at either the above-named permit drafter's office or the above-named basin engineer's office. Any interested person may comment upon the proposed AEL(s) for Temperature.

Persons wishing to comment on or object to the proposed permit action, or to request a public hearing, may write to the Department of Natural Resources at the above-named permit drafter's address. All comments or suggestions received no later than 30 days after the publication date of this public notice will be considered along with other information on file in making a final decision regarding the permit. Anyone providing comments in response to this public notice will receive a notification of the Department's final decision when the permit is issued. Where designated as a reviewable surface water discharge permit, the U.S. Environmental Protection Agency is allowed up to 90 days to submit comments or objections regarding this permit determination. If no comments are received on the proposed permit from anyone, including U.S. EPA, the permit will be issued as proposed.

The Department may schedule a public informational hearing if requested by any person and shall schedule a public informational hearing if a petition requesting a hearing is received from 5 or more persons or if response to this notice indicates significant public interest pursuant to s. 283.49, Wis. Stats. Requests for a public informational hearing shall state the following: the name and address of the person(s) requesting the hearing; the interest in the proposed permit of the person(s) requesting the hearing; the reasons for the request; and the issues proposed to be considered at the hearing.

Information on file for this permit action, including the draft permit, fact sheet and permit application, may be inspected and copied at either the above-named permit drafter's office or the above named basin engineer's office, Monday through Friday (except holidays), between 9:00 a.m. and 3:30 p.m. Please call the permit drafter or basin engineer for directions to their office location, if necessary.
