Location: Surface water and groundwater within the Bear Creek and City of Spring Green-Wisconsin River Watersheds

Brief Facility Description : The Hanor Company of Wisconsin LLC is a large swine production operation composed of two sites in Sauk County. The Main Farm includes 14 swine barns with connecting hallways, connecting swine holding areas, a load out facility, an incinerator, a two-stage waste storage facility system and three groundwater monitoring wells. The Truck Wash station at the Main Office site includes two holding tanks for process wastewater from the truck washing process, as well as a roofed, solid stacking area for truck bedding. The operation houses 3,328 animal units (5,000 pigs up to 55 lbs, 5,600 pigs 55 lbs to market, 1,450 sows, and 15 boars). With a herd this size, the facility will generate approximately 10,537,323 gallons of manure and process wastewater annually. The Hanor Company of Wisconsin LLC currently has 1,751.6 acres in their conditionally approved 5-year nutrient management plan, of which 1,610.5 are spreadable acres. Currently there are no planned expansions in the next permit term, and this will be sixth WPDES permit reissuance for the operation.

The Department has tentatively decided that the above specified WPDES permit should be reissued.

The Department may schedule a public informational hearing if within 30 days of the public date of this notice, a request for a hearing is filed by any person. The Department shall schedule a public informational hearing if a petition requesting a hearing is received from USEPA or from 5 or more persons or if the Department determines there is significant public interest. Requests for a public informational hearing shall state the following: the name and address of the person(s) requesting the hearing; the interest in the proposed permit of the person(s) requesting the hearing; the reasons for the request; and the issues proposed to be considered at the hearing.
