PUBLIC NOTICE OF INTENT TO MODIFY A WISCONSIN POLLUTANT DISCHARGE ELIMINATION SYSTEM (WPDES) PERMIT No.WI-0049689-05-1

Permittee: Hub Rock Sanitary District #1, 16977 State Road 80, Richland Center, WI, 53581

Facility Where Discharge Occurs: Hub Rock Sanitary District #1 WWTF, CTH "DD", ROCKBRIDGE, WISCONSIN

Receiving Water And Location: Pine River (Upper Pine River Watershed, LW13, Lower Wisconsin River Basin) in Richland County

Brief Facility Description: Hub Rock Sanitary District #1 operates a wastewater treatment facility serving a population of approximately 100 residents in the Town of Rockbridge and the unincorporated community of Hub City. Treatment consists of two aerated lagoons operated in series, with four cells for treatment, followed by chlorine contact disinfection and dechlorination prior to discharge to the Pine River. The system is designed to treat an annual average of 0.0256 MGD of domestic wastewater and presently receives an average of 0.024 MGD for treatment annually. The permittee has been found to be in substantial compliance with its current permit. Shaded cells indicate changes to sampling or limitations.

Proposed Modification: The modification was to change the permit to document the addition of the Water Quality Trading monitoring, schedule, and language for phosphorus (see gray shaded additions) along with the removal of the phosphorus Multi Discharger Variance monitoring, schedule, and language.

The Department has tentatively decided that the above-specified WPDES permit should be modified. Limitations and conditions which the Department believes adequately protect the receiving water are included in the proposed permit. Land application of waste shall be done in accordance with permit conditions and applicable codes. All land application sites shall be approved prior to their use. To receive a list of approved sites, or to be notified of potential approvals, contact the above-named basin engineer.

Persons wishing to comment on or object to the proposed permit action, or to request a public hearing, may write to the Department of Natural Resources at the above-named permit drafter's address. All comments or suggestions received no later than 30 days after the publication date of this public notice will be considered along with other information on file in making a final decision regarding the permit. Anyone providing comments in response to this public notice will receive a notification of the Department's final decision when the permit is issued. Where designated as a reviewable surface water discharge permit, the U.S. Environmental Protection Agency is allowed up to 90 days to submit comments or objections regarding this permit determination. If no comments are received on the proposed permit from anyone, including U.S. EPA, the permit will be issued as proposed.

The Department may schedule a public informational hearing if requested by any person and shall schedule a public informational hearing if a petition requesting a hearing is received from 5 or more persons or if response to this notice indicates significant public interest pursuant to s. 283.49, Wis. Stats. Requests for a public informational hearing shall state the following: the name and address of the person(s) requesting the hearing; the interest in the proposed permit of the person(s) requesting the hearing; the reasons for the request; and the issues proposed to be considered at the hearing.

Information on file for this permit action, including the draft permit, fact sheet and permit application, may be inspected and copied at either the above-named permit drafter's office or the above named basin engineer's office, Monday through Friday (except holidays), between 9:00 a.m. and 3:30 p.m. Please call the permit drafter or basin engineer for directions to their office location, if necessary.
