PUBLIC NOTICE OF INTENT TO REISSUE A WISCONSIN POLLUTANT DISCHARGE ELIMINATION SYSTEM (WPDES) PERMIT No.WI-0003883-11-0

Permittee: Maple Island, INC., 335 S Wisconsin Ave, Medford, WI, 54451

Facility Where Discharge Occurs: Maple Island Inc, 335 South Wisconsin Avenue, Medford, Wisconsin

Receiving Water And Location: The Black River within the Black and Little Black Rivers Watershed in the Black, Buffalo, and Trempealeau Rivers Drainage Basin in Taylor County

Brief Facility Description and Summary of Proposed Changes: Maple Island, Inc. is a food processing facility that blends, agglomerates and packages food powders, primarily dairy powders. Process wastewater is produced by washing equipment, wet scrubber cleaning, boiler water, and agglomeration water.

Maple Island operates a three-stage wastewater treatment facility consisting of two stabilization ponds followed by a holding pond. Effluent is normally transferred to the Medford Wastewater Treatment Facility for additional treatment and then discharged. However, the facility maintains the capability to discharge to the Black River through Outfall 001.

It is the Department's intention to renew the permit for another term. The proposed new permit expiration date will be September 30, 2029. Limitations and conditions which the Department believes adequately protect the receiving water are included in the proposed permit.

Persons wishing to comment on or object to the proposed permit action, or to request a public hearing, may write to the Department of Natural Resources at the above-named permit drafter's address. All comments or suggestions received no later than 30 days after the publication date of this public notice will be considered along with other information on file in making a final decision regarding the permit. Anyone providing comments in response to this public notice will receive a notification of the Department's final decision when the permit is issued. Where designated as a reviewable surface water discharge permit, the U.S. Environmental Protection Agency is allowed up to 90 days to submit comments or objections regarding this permit determination. If no comments are received on the proposed permit from anyone, including U.S. EPA, the permit will be issued as proposed.

The Department may schedule a public informational hearing if requested by any person and shall schedule a public informational hearing if a petition requesting a hearing is received from 5 or more persons or if response to this notice indicates significant public interest pursuant to s. 283.49, Wis. Stats. Requests for a public informational hearing shall state the following: the name and address of the person(s) requesting the hearing; the interest in the proposed permit of the person(s) requesting the hearing; the reasons for the request; and the issues proposed to be considered at the hearing.

Information on file for this permit action, including the draft permit, fact sheet and permit application, may be inspected and copied at either the above-named permit drafter's office or the above named basin engineer's office, Monday through Friday (except holidays), between 9:00 a.m. and 3:30 p.m. Please call the permit drafter or basin engineer for directions to their office location, if necessary.
