PUBLIC NOTICE OF INTENT TO REISSUE A WISCONSIN POLLUTANT DISCHARGE ELIMINATION SYSTEM (WPDES) PERMIT No. WI-0061115-10-0

Permittee: Village of Solon Springs, PO Box 273, Solon Springs, WI, 54873

Facility Where Discharge Occurs: Village of Solon Springs, 12071 S. Holly Lucius Road, Solon Springs, Wisconsin

Receiving Water And Location: Groundwater of the Upper St. Croix and Eau Claire Rivers Watershed in the St. Croix River Drainage Basin in Douglas County

Brief Facility Description and Summary of Proposed Changes: The Village of Solon Springs owns and operates a wastewater treatment facility. The plant designed to treat 107,000 gallons per day currently treats an average of 104,000 gallons per day (June 2019 – June 2024 data) from the Village of Solon Springs, Upper St Croix Lake Sanitary District and Gordon Sanitary District #1. The system consists of three stabilization ponds operated in series. In each pond naturally occurring bacteria already in the wastewater treat the waste stream by metabolizing organic matter. From the ponds the treated water (called effluent) is discharged to two seepage cells. The sandy soil in the bottom of the seepage cells continues to treat the water further, as it percolates through the soil eventually reaching groundwater. There are three monitoring wells located around the seepage cells to assess any groundwater impacts of the discharge.

It is the Department's intention to renew the permit for another term. The proposed new permit expiration date will be December 31, 2029. Limitations and conditions which the Department believes adequately protect the receiving water are included in the proposed permit. Changes from the previous permit include: [1] Groundwater monitoring for pH Lab is not needed and has been removed. [2] The preventative action limits (PALs) for nitrite + nitrate, organic nitrogen, and total dissolved solids have been adjusted per NR 140 Wis. Adm. Code. [3] Sludge monitoring for metals, PCBs and PFOA+PFAS is required in 2026. [4] A schedule for an updated Land Treatment Management Plan is required.

Persons wishing to comment on or object to the proposed permit action, or to request a public hearing, may write to the Department of Natural Resources at the above-named permit drafter's address. All comments or suggestions received no later than 30 days after the publication date of this public notice will be considered along with other information on file in making a final decision regarding the permit. Anyone providing comments in response to this public notice will receive a notification of the Department's final decision when the permit is issued. Where designated as a reviewable surface water discharge permit, the U.S. Environmental Protection Agency is allowed up to 90 days to submit comments or objections regarding this permit determination. If no comments are received on the proposed permit from anyone, including U.S. EPA, the permit will be issued as proposed.

The Department may schedule a public informational hearing if requested by any person and shall schedule a public informational hearing if a petition requesting a hearing is received from 5 or more persons or if response to this notice indicates significant public interest pursuant to s. 283.49, Wis. Stats. Requests for a public informational hearing shall state the following: the name and address of the person(s) requesting the hearing; the interest in the proposed permit of the person(s) requesting the hearing; the reasons for the request; and the issues proposed to be considered at the hearing.

Information on file for this permit action, including the draft permit, fact sheet and permit application, may be inspected and copied at either the above-named permit drafter's office or the above named basin engineer's office, Monday through Friday (except holidays), between 9:00 a.m. and 3:30 p.m. Please call the permit drafter or basin engineer for directions to their office location, if necessary.
