PUBLIC NOTICE OF INTENT TO REISSUE A WISCONSIN POLLUTANT DISCHARGE ELIMINATION SYSTEM (WPDES) PERMIT No.WI-0022373-11-0

Permittee: Village of Spring Valley, P O Box 276, Spring Valley, WI, 54767

Facility Where Discharge Occurs: Spring Valley Wastewater Treatment Facility, Hwy 29, Spring Valley, WI

Receiving Water And Location: Eau Galle River in Eau Galle River Watershed of Lower Chippewa River Basin in Pierce County

Brief Facility Description: The Village of Spring Valley owns and operates the Spring Valley Wastewater Treatment Facility. The annual average design flow of the facility is 0.157 million gallons per day (MGD), and the actual annual average effluent flow in 2025 was 0.087 MGD. Treatment consists of a vertical screen, vortex grit removal, sequencing batch reactor (reactor (SBR) and post equalization. Phosphorus is removed chemically using an alum feed system. Effluent is disinfected seasonally via ultraviolet radiation prior to discharge to the Eau Galle River. Sludge is shipped to the West Central Wisconsin Biosolids Facility.

The Department has tentatively decided that the above-specified WPDES permit should be reissued.

Limitations and conditions which the Department believes adequately protect the receiving water are included in the proposed permit. Land application of waste shall be done in accordance with permit conditions and applicable codes. All land application sites shall be approved prior to their use. To receive a list of approved sites, or to be notified of potential approvals, contact the above-named basin engineer.

Phosphorus Multi-Discharger Variance: The Department has determined that the permittee is eligible for a phosphorus multi-discharger variance (MDV) in accordance with s. 283.16, Wis. Stats. The MDV provides a time extension for the permittee to comply with the final water quality based effluent limits for phosphorus while implementing a specific watershed project to reduce phosphorus. Comments on this determination are requested and additional supporting documentation and data are available upon request.

Persons wishing to comment on or object to the proposed permit action, or to request a public hearing, may write to the Department of Natural Resources at the above-named permit drafter's address. All comments or suggestions received no later than 30 days after the publication date of this public notice will be considered along with other information on file in making a final decision regarding the permit. Anyone providing comments in response to this public notice will receive a notification of the Department's final decision when the permit is issued. Where designated as a reviewable surface water discharge permit, the U.S. Environmental Protection Agency is allowed up to 90 days to submit comments or objections regarding this permit determination. If no comments are received on the proposed permit from anyone, including U.S. EPA, the permit will be issued as proposed.

The Department may schedule a public informational hearing if requested by any person and shall schedule a public informational hearing if a petition requesting a hearing is received from 5 or more persons or if response to this notice indicates significant public interest pursuant to s. 283.49, Wis. Stats. Requests for a public informational hearing shall state the following: the name and address of the person(s) requesting the hearing; the interest in the proposed permit of the person(s) requesting the hearing; the reasons for the request; and the issues proposed to be considered at the hearing.

Information on file for this permit action, including the draft permit, fact sheet and permit application, may be inspected and copied at either the above-named permit drafter's office or the above named basin engineer's office, Monday through Friday (except holidays), between 9:00 a.m. and 3:30 p.m. Please call the permit drafter or basin engineer for directions to their office location, if necessary. Information on this permit action may also be obtained by calling the permit drafter at (715) 492-0483 or by writing to the Department. Reasonable costs (15 cents per page for copies and 7 cents per page for scanning) will be charged for information in the file other than the public notice, permit and fact sheet.
