PUBLIC NOTICE OF INTENT TO REISSUE A WISCONSIN POLLUTANT DISCHARGE ELIMINATION SYSTEM (WPDES) PERMIT No.WI-0023639-11-0

Permittee: Village of Clear Lake, P O Box 181, Clear Lake, WI, 54005-0048

Facility Where Discharge Occurs: Village of Clear Lake , 366 South Avenue East, Clear Lake, Wisconsin

Receiving Water And Location: Unnamed Tributary to the Willow River Within the Upper Willow River Watershed in the St. Croix River Drainage Basin in Polk County

Brief Facility Description: The Village of Clear Lake owns and operates a domestic wastewater treatment system that consists of automated bar screening and grit removal, primary clarifier, first stage Moving Bed Biological Reactor (MBBR), intermediate clarifier, second stage MBBR and final clarifier with chemical phosphorus removal using ferric chloride and tertiary treatment for final phosphorus removal. Settled solids (sludge) removed from the clarifiers are treated through aerobic digestion and land applied on Department approved agricultural sites.

Limitations and conditions which the Department believes adequately protect the receiving water are included in the proposed permit. Land application of waste shall be done in accordance with permit conditions and applicable codes. All land application sites shall be approved prior to their use. Persons wishing to comment on or object to the proposed permit action, or to request a public hearing, may write to the Department of Natural Resources at the above-named permit drafter's address. All comments or suggestions received no later than 30 days after the publication date of this public notice will be considered along with other information on file in making a final decision regarding the permit. Anyone providing comments in response to this public notice will receive a notification of the Department's final decision when the permit is issued. Where designated as a reviewable surface water discharge permit, the U.S. Environmental Protection Agency is allowed up to 90 days to submit comments or objections regarding this permit determination. If no comments are received on the proposed permit from anyone, including U.S. EPA, the permit will be issued as proposed.

The Department may schedule a public informational hearing if requested by any person and shall schedule a public informational hearing if a petition requesting a hearing is received from 5 or more persons or if response to this notice indicates significant public interest pursuant to s. 283.49, Wis. Stats. Requests for a public informational hearing shall state the following: the name and address of the person(s) requesting the hearing; the interest in the proposed permit of the person(s) requesting the hearing; the reasons for the request; and the issues proposed to be considered at the hearing.

Information on file for this permit action, including the draft permit, fact sheet and permit application, may be inspected and copied at either the above-named permit drafter's office or the above named basin engineer's office, Monday through Friday (except holidays), between 9:00 a.m. and 3:30 p.m. Please call the permit drafter or basin engineer for directions to their office location, if necessary.
