PUBLIC NOTICE OF INTENT TO REISSUE A WISCONSIN POLLUTANT DISCHARGE ELIMINATION SYSTEM (WPDES) PERMIT No.WI-0021440-09-0

Permittee: Village of Fairwater, P O BOX 15, FAIRWATER, WI, 53931

Facility Where Discharge Occurs: Fairwater Wastewater Treatment Facility, Highway 44 South, Fairwater, Wisconsin

Receiving Water and Location: Tributary to the Grand River, in the "Upper Grand River Watershed" (UF 12) in the Upper Fox River Basin

Brief Facility Description: The Village of Fairwater, in western Fond du Lac County, owns and operates a twostage, recirculating sand filter wastewater treatment facility. This facility was designed for an average annual flow of 0.051 MGD (51,000 gallons per day) and constructed in 2004 on the site of an older WWTF that consisted of a 2cell stabilization pond which has been properly abandoned, although the ponds remain for wildlife value. Treated effluent is discharged to a tributary to the Grand River via Outfall 004, located at approximately Latitude 43° 44' 12" North and Longitude 88° 52' 55" West, in the "Upper Grand River Watershed" (UF 12) in the Upper Fox River Basin. Solid residuals are stored in septic tanks and septage is not anticipated to be removed during this permit term.

The Department has tentatively decided that the above-specified WPDES permit should be reissued.

<u>Phosphorus Multi-Discharger Variance</u>: The Department has determined that the permittee is eligible for a phosphorus multi-discharger variance (MDV) in accordance with s. 283.16, Wis. Stats. The MDV provides a time extension for the permittee to comply with the final water quality based effluent limits for phosphorus while contributing funds towards nonpoint pollution control projects to reduce phosphorus. Comments on this determination are requested and additional supporting documentation and data are available upon request.

Persons wishing to comment on or object to the proposed permit action, or to request a public hearing, may write to the Department of Natural Resources at the above-named permit drafter's address. All comments or suggestions received no later than 30 days after the publication date of this public notice will be considered along with other information on file in making a final decision regarding the permit. Anyone providing comments in response to this public notice will receive a notification of the Department's final decision when the permit is issued. Where designated as a reviewable surface water discharge permit, the U.S. Environmental Protection Agency is allowed up to 90 days to submit comments or objections regarding this permit determination. If no comments are received on the proposed permit from anyone, including U.S. EPA, the permit will be issued as proposed.

The Department may schedule a public informational hearing if requested by any person and shall schedule a public informational hearing if a petition requesting a hearing is received from 5 or more persons or if response to this notice indicates significant public interest pursuant to s. 283.49, Wis. Stats. Requests for a public informational hearing shall state the following: the name and address of the person(s) requesting the hearing; the interest in the proposed permit of the person(s) requesting the hearing; the reasons for the request; and the issues proposed to be considered at the hearing.

Information on file for this permit action, including the draft permit, fact sheet and permit application, may be inspected and copied at either the above-named permit drafter's office or the above named basin engineer's office, Monday through Friday (except holidays), between 9:00 a.m. and 3:30 p.m. Please call the permit drafter or basin engineer for directions to their office location, if necessary.
