PUBLIC NOTICE OF INTENT TO REISSUE A WISCONSIN POLLUTANT DISCHARGE ELIMINATION SYSTEM (WPDES) PERMIT No.WI-0025453-11-0

Permittee: Village of Sheldon, W5559 Main Street, Sheldon, WI, 54766

Facility Where Discharge Occurs: Village of Sheldon, W5871 County Highway V V, Sheldon, Wisconsin

Receiving Water And Location: Jump River in the Lower Jump River Watershed in the Upper Chippewa River Drainage Basin in Rusk County

Brief Facility Description: The Village of Sheldon owns and operates a domestic wastewater treatment system that consists of three aerated lagoons operated in series. The effluent (treated wastewater) is seasonally (May-September) disinfected with an ultraviolet system prior to discharge into the Jump River.

The Department has tentatively decided that the above-specified WPDES permit should be reissued. It is the Department's intention to renew the permit for another term. Limitations and conditions which the Department believes adequately protect the receiving water are included in the proposed permit.

Persons wishing to comment on or object to the proposed permit action, or to request a public hearing, may write to the Department of Natural Resources at the above-named permit drafter's address. All comments or suggestions received no later than 30 days after the publication date of this public notice will be considered along with other information on file in making a final decision regarding the permit. Anyone providing comments in response to this public notice will receive a notification of the Department's final decision when the permit is issued. Where designated as a reviewable surface water discharge permit, the U.S. Environmental Protection Agency is allowed up to 90 days to submit comments or objections regarding this permit determination. If no comments are received on the proposed permit from anyone, including U.S. EPA, the permit will be issued as proposed.

The Department may schedule a public informational hearing if requested by any person and shall schedule a public informational hearing if a petition requesting a hearing is received from 5 or more persons or if response to this notice indicates significant public interest pursuant to s. 283.49, Wis. Stats. Requests for a public informational hearing shall state the following: the name and address of the person(s) requesting the hearing; the interest in the proposed permit of the person(s) requesting the hearing; the reasons for the request; and the issues proposed to be considered at the hearing.

Information on file for this permit action, including the draft permit, fact sheet and permit application, may be inspected and copied at either the above-named permit drafter's office or the above named basin engineer's office, Monday through Friday (except holidays), between 9:00 a.m. and 3:30 p.m. Please call the permit drafter or basin engineer for directions to their office location, if necessary. Reasonable costs (15 cents per page for copies and 7 cents per page for scanning) will be charged for information in the file other than the public notice, permit and fact sheet.
