PUBLIC NOTICE OF INTENT TO MODIFY A WISCONSIN POLLUTANT DISCHARGE ELIMINATION SYSTEM (WPDES) PERMIT No.WI-0020001-10-2

Permittee: Whitewater Wastewater Treatment Facility, PO Box 178, Whitewater, WI 53190

Facility Where Discharge Occurs: Whitewater Wastewater Treatment Facility, 109 County Hwy U, Whitewater, WI 53190

Receiving Water And Location: Whitewater Creek (Whitewater Creek Watershed, LR14 - Lower Rock River Basin) in Jefferson County

Brief Facility Description: The City of Whitewater Wastewater Treatment Facility (WWTF) serves a population of approximately 14,500 people as well as several significant industries. The WWTF is designed to treat an annual flow of 3.65 MGD. The WWTF consists of preliminary (bar screen, grit removal and cleaning) treatment, primary clarification, secondary treatment (RBCs), chemical phosphorus treatment, secondary clarification, tertiary filtration (deep bed anthracite), and UV disinfection prior to discharge to Whitewater Creek. Biosolids are treated with anaerobic digestion, stored as a liquid and land applied on approved sites. Currently, the Whitewater WWTF is treating approximately 1.35 MGD and generating 175 metric tons of biosolids on an annual basis.

Proposed Modification: The permit modification is proposed to reduce the effluent PFOS/PFOA sampling frequency from 1/ 2 months to quarterly, after a review of submitted data, pursuant to s. NR 205.066, Wis. Adm. Code.

The Department has tentatively decided that the above-specified WPDES permit should be modified.

Persons wishing to comment on or object to the proposed permit action, or to request a public hearing, may write to the Department of Natural Resources at the above-named permit drafter's address. All comments or suggestions received no later than 30 days after the publication date of this public notice will be considered along with other information on file in making a final decision regarding the permit. Anyone providing comments in response to this public notice will receive a notification of the Department's final decision when the permit is issued. Where designated as a reviewable surface water discharge permit, the U.S. Environmental Protection Agency is allowed up to 90 days to submit comments or objections regarding this permit determination. If no comments are received on the proposed permit from anyone, including U.S. EPA, the permit will be issued as proposed.

The Department may schedule a public informational hearing if requested by any person and shall schedule a public informational hearing if a petition requesting a hearing is received from 5 or more persons or if response to this notice indicates significant public interest pursuant to s. 283.49, Wis. Stats. Requests for a public informational hearing shall state the following: the name and address of the person(s) requesting the hearing; the interest in the proposed permit of the person(s) requesting the hearing; the reasons for the request; and the issues proposed to be considered at the hearing.

Information on file for this permit action, including the draft permit, fact sheet and permit application, may be inspected and copied at either the above-named permit drafter's office or the above named basin engineer's office, Monday through Friday (except holidays), between 9:00 a.m. and 3:30 p.m. Please call the permit drafter or basin engineer for directions to their office location, if necessary.
