# PRIVATE WATER ADVISORY COUNCIL Meeting Notes – January 7, 2015

# **Advisory Council Procedures and Membership**

Council discussed an updated Advisory Council Procedures document dated January 7, 2015. Members suggested several edits, including reference the addition of Heat Exchange Drilling. Each appointing organization updated their member appointments. DNR will complete updated appointments prior to April meeting and provide a final membership roster. The Council will adopt the final procedures and elect a co-chair at the next meeting.

# **Private Water Supply Program Updates**

## 1. Staff

Marty Nessman has been hired as DNR's Private Water Field Supervisor, a new position to provide additional management support for the field program. Randell Clark moved to the Private Water section, and will continue to work on geothermal reviews and landfill variances. Tom Riewe retired from his LTE position in December 2014.

## 2. Well Construction and Licensing Data

Liesa shared 2 graphs showing Well Construction Report data from the past 10 years. Council members expressed an interest in seeing additional data in the future, including Filled and Sealed Wells (replacement v. unused), Heat Exchange Projects and Drillholes, and Private Wells (new v. replacement).

## 3. Heat Exchange Licensing

DNR staff continues to review Heat Exchange Driller (HED) License applications. Of the 62 HED applications received to-date:

- 15 eligible for January 8 exam
- 21 pending for later exam date
- 8 incomplete waiting for additional information
- 5 late not yet processed
- 13 out-of-state not yet processed

HED exams will be offered at all January, February and March Continuing Ed sessions so licenses can be issued before April 1. HED license is required to drill heat exchange system effective April 1, 2015. An issue has come up regarding applicants who are supervisory drillers and/or have been in the industry a long time, but do not qualify under NR 146 code requirements because their drilling experience is more than 5 years ago. State statute allows DNR to establish alternative eligibility requirements for individuals with older experience, so DNR is developing guidance. Council members requested more flexibility, and gave input on what criteria should be included in alternative eligibility requirements.

# 4. Heat Exchange Drilling Notification

Effective April 1, "small" heat exchange drilling projects will require an electronic notification to DNR instead of a prior written approval. The notification system will be similar to the current Well Notification system. No \$50 fee. The 2015 Continuing Education booklet contains a summary of when a notification is required (see page 24).
