# Meeting Agenda

#### 1. Welcome and Introductions:

- Attendees: Nessman, Fetter, Chase, Walker, Niewoehner, Kuhn, Burton, Hanten, Gundrum, Tessmer, Beiriger, Buttke, Farago, Lang, Haupt.
- 2. **PWAC membership and terms** no one is on their 4<sup>th</sup> term and has an expiring term. Nessman recommended that everyone with an expiring term extend for one more term...all present agreed.

# 3. PFAS Update (Burton) - Gundrum takes notes...

Last updated the PWAC in Oct 2019 – gave a refresher. See slides. What's new: see slides.

- Burton last reported on PFAs October of 2019 -
- Beiriger: From driller perspective, what part of developing rules may affect the
  private water industry? Burton Drillers should know that they may need to
  address customer questions regarding PFAS. People need to be aware if there
  is investigation... be able to give information if asked. Recommendations on how
  drill if present. We want drillers to be knowledgeable about PFAS and
  developments. DNR would like to share information to the industry so they are
  aware of what and where the issues related to PFAS are.
- Hanten: We are already seeing inquiries and sample testing requests. PFAS
  has been found in private wells. PFAS has been found in private well in
  LaCrosse.
- Burton: common questions that people might be getting in the industry come up and department wants to work with the industry to help them to answer questions
- Beiriger: Real estate transactions and ruling may trickle down from who was responsible for the source to the property owner be responsible for dealing with the issue in a real estate transaction.
- Chase: Are there any special casing requirements in areas with known PFAS plumes?
- Nessman: none at the moment. There are some known areas, but department does not have complete understanding of the extent and data is not available. Department will not respond unless there is a clear picture of the scope and extent.
- Burton: PFAS is everywhere. Scope and extent is difficult to determine.
- Hanten: Will 16 additional PFAS recommendations be added to current regulations. Potential for add-ons for years to come.

- Burton: EPA is looking at requirements and it is being reviewed by current administration.
- Walker: This is still emerging, and we have no idea at this point how we will address a PFAS problem. If asked what should be done to mitigate a known PFAS issue, we would have no idea how to respond. We do not yet know what the construction criteria needed to address a known problem.
- Nessman: Would be case specific. You would need to contact the department would be case by case situation.
- Burton: Just have conventional knowledge now but would like to work with people. Industry should contact regional representative when questions come up.
- Walker: Is PFAS more or less dense than water?
- Burton: We have seen in sand and gravel aquifers spread throughout top to bottom.
- Nessman: It is somewhat hydrophobic plume
- Kuhn: Will requirements be added to OTMs and NNs for testing?
- Burton: This part of NR 809 development may be part of 2022 rule promulgation
- Hanten: This is a new category. Will not be part of SOCs.
- Hanten: Are the department's efforts on hold waiting for federal regulation.
- Burton: State will move forward and not wait for EPA or federal regulation.

# 5. October 2020 Meeting Notes

- 6. WGNHS Updates Pete Chase COVID-19 impacts on the survey. Preemptive furloughs (9 days total since the beginning of the pandemic. Statewide Gndwater monitoring network contracted to do 2 of 12 wells (Milw, and Rock Co,). Others, including dave, Buffalo and Waushara counties. Targeted areas near where water use has increased (irrigation wells and new suburban devel). Airborne electromagnetic survey in NE counties with shallow bedrock 2-3 week operation starting this week (Wx permitting). Depth to bedrock (important to DATCP) accurate depths, to 200-300' can help with Silurian Dolomite and Maquoketa shale formation locations. Ground-truthing with borings along a 3-mile stretch of the air route. Pretty much done with the central sands lake study in Waushara County. A lot of computing power and elaborate monitoring about turning on/off wells, etc. Public hearings on this in June. DNR webpage has some preliminary findings. Continuing with bedrock mapping projects in Green, Lafayette, Grant, Jefferson

## 7. DNR Updates

- a) Staffing Updates (Nessman)
  - Sandy position vacant for 1 year, Mattias leaving Feb. 10<sup>th</sup>. Moving back to Sweden. No approval yet to fill as a full-time position.

- Position posted for new LTE for Sandy position. 22 resumes being reviewed.
- o Expect new LTE position to be filled around March 1st.
- o Position authority frozen until budget considerations complete.
- Field supervisor vacancy Temporary assignments set to June. Hope to fill the position before June.
  - Position to be advertised and can be located anywhere around the state.
  - ii. Beiriger: Would it be helpful for the industry to send a letter to the Secretaries office to encourage them to make the funding available?
  - iii. Nessman: Will pass it on to Steve Elmore.
- b) Private Water Program Priorities (Nessman)
  - WCRs data entry improvements and geology coding target January 2023.
  - Notification system adding functionality. Survey in progress to determine improvements needed.
    - i. Farago: would be helpful to include high-cap notifications.
    - ii. Hanten: Data entry for labs through data transfer still not available?
    - iii. Nessman: We have a workgroup looking at current database (dated) as far as what needs to be upgraded. Would consider this as being part of that effort.
    - iv. Would make sense to have this process tie into public water capabilities that already exist.
  - For environmental licensing system, looking at adding capability to view continuing education credit status online. Increase this year in online license renewals. Paper application process has experienced delays that are being worked out.
  - NR 812 Variance system to be improved to allow submitting variance applications online.

    - ii. GovDelivery will focus on important issues that industry needs to know
    - iii. Will record DNR update and post to website or to training providers.
      - 1. Looking for input on how to best serve the industry with these updates.... Format
    - iv. Future rule revisions
      - 1. Possible internal/external workgroups to be developed to plan approach with pump installation.
      - 2. Well compensation currently does not address well abandonment grants or well affected by livestock waste.
      - 3. Any ideas in the industry on rule revision should be shared with the department for consideration.
    - v. Hanten: Who will be the keeper of concerns? Concerns should be directed to Frank.
    - vi. Fetter: Currently having tracking spreadsheets in place for this purpose.
    - vii. Hanten: Any discussion with WWWA on DNR content and what WWWA is doing online this year. Historically the department has been a part of that this should continue even though things are virtual.
    - viii. Beiriger: This is an important part of the WWWA offerings.
    - ix. Jennifer to contact Nessman to get this set up. Would be 1 hour on DNR updates.
