







- NONs since October 27, 2022: 2
- Most Common Violations:
 - Location/Separation Distance
 - Unlicensed Work (mostly PI)
 - Noncompliant Electrical Conduit
 - Reporting (various)




Compliance & Enforcement

- Secondary enforcement:
 - NOVs issued in 2022:
 - WD Noncompliant Grouting
 - WD Noncompliant HEX construction
 - Citations issued, 2022 = 2
 - Active cases: 2
 - Pending Cases: 4
 - WD/PI Unlicensed WD/PI work (3 Cases)
 - PI Working on Noncompliant System
- Referrals to DOJ:
 - 1 current DOJ referral (2017)
 STILL awaiting legislative closure




NR 812 Rule Revisions

- Board Order DG-07-22(E) & DG-08-22
 - Type IL Cement Added to NR 812
 - Emergency Rule Approved by NRB 12/14/22
 - Emergency rule in effect as of 01/12/23
 - Next hearing on both rules 03/22/23



NR 146 Scope Statement



- Draft rule language may not be started before a Scope Statement is approved by the Natural Resources Board
 - Advisory committee (if necessary) to start work after Scope Statement Approved
- Scope Statement for NR 146
- Objectives:
 - Correct grammatical, spelling and punctuation errors
 - Address redundancies, omissions and clarify to improve understanding and readability
 - Update continuing education, renewal and license application requirements to coincide with current processes

NR 812 Scope Statement


- Draft rule language may not be started before a Scope Statement is approved by the Natural Resources Board
 - Advisory committee to start work after Scope Statement Approved
- Scope Statement for NR 812
 - Scope will be contained to Subchapter III only (Pump Installation)
 - Objectives:
 - Correct grammatical, spelling and punctuation errors
 - Address redundancies, omissions and clarify to improve understanding and readability
 - Pump Installer Requirements
 - Non-Electric Pump and System Installations
 - Water Storage Vessels
 - Water Treatment
 - Hand Pumps
 - Vermin-Proof Well Caps and Seals
 - Yard Hydrants






PUMP INSTALLER - 12/31/2022




WATER WELL DRILLER – 12/31/2022

Rig Operator Training

Required Training:

- Cement or bentonite grouting of wells 6 hours
- Drilling Fluids 6 hours
- Geology of Wisconsin 3 hours
- Well codes 6 hours
- Well filling and sealing 3 hours
- Safety and first aid 3 hours
- Welding 6 hours



Approach:

- Communicating with those who have expressed interest or applied
- Review past training that may apply
- Assess and compile training needs of the group
- Identify training opportunities
- Establish training plans

Rig Operator Training - Welding

- 2G Welding Certification at Accredited Test Facility
- Hands-on qualification test conducted by certified welding inspector

Pipe Welding Certification Positions

When it comes to welding pipe there are four main positions and again they are typically groove welds. There is also a coding system to identify the positions and joint types. They are as follows:

- 1 is for a pipe in the horizontal position that is rolled.
- 2 is for a pipe in the fixed vertical position.
- 5 is for a pipe in the fixed horizontal position.
- 6 is for a pipe in a 45 degree fixed position.
- R is for the restricted position.

 - Sampled one well from each section of grid
 - Shallow groundwater sampling

Study of ambient PFAS in drinking water

- Divided state into 450 grid cells
- Sampled one well from each section of grid
- Shallow groundwater sampling



Initial overview of PFAS results

- 29% had no detections of any PFAS
- 70% detected PFAS but below recommended GW standards
- 0.7% detected PFAS above recommended GW standard

Oneida County

- Town of Stella detections above recommended standards
- Temporary water is being provided
- No identified source
- No clear long-term solution
- Working to find additional resources
