




**Online vs Mailed Renewal Application Processing** 






Percentage of Private Water Renewals Processed Online

#### PUMP INSTALLER (PIP) / PUMP INSTALLING BUSINESS (PIB) 10-YR TREND




#### WATER WELL DRILLER (WDP) / WELL DRILLING BUSINESS (WDB) 10-YR TREND





## NR 146 Rule Revision High Points

- Mandatory online renewal
  - Online renewal requirement can be waived with legitimate reason
    - Those granted waiver will renew by mail.
    - Those granted a waiver must complete CE before October 15.
      - If CE is not completed by October 15, renewal must be processed online.
    - Applications for mailed renewals will be sent out mid to late October.
- Qualified welder definition and requirements:
  - "Qualified welder" means an individual who holds a welding certification or who has passed a 2G vertical fixed pipe welding performance test administered by a certified welding instructor. (See license exceptions <u>NR</u> <u>146.03(2)(c)6</u> & <u>146.03(2)(d)7</u>).

## NR 146 Rule Revision High Points

- Clarification on Supervisory Roles and Responsibilities
- Licenses and rig operator registrations issued after October 31 will expire on December 31 occurring after license or registration has been in effect for one year.
- Rig operator training hours reduced.
  - 2G vertical fixed pipe performance qualification test accepted for welding requirement.
  - Training requirements specified for Heat Exchange license applicants
  - Grouting / Filling and Sealing combined and set to 6 hours
  - Drilling fluids reduced from 6 to 3 hours
  - Wisconsin Well Codes reduced from 6 to 4 hours

## NR 146 Rule Revision High Points

- Required Continuing Education
  - One credit of code compliance related training required
  - Three credits specific to the license held is required
  - Business related training accepted for credit
  - Training specific to other license types accepted for credit
  - One year grace period for completing continuing education attendance.
- Heat exchange driller license required to fill and seal heat exchange drillholes.

## **Required WD License Training - Welding**

- Performance qualification testing at accredited test facilities.
  - Wisconsin Welding Schools
- Welding instructors are developing 6-hour training specifically tailored to Wisconsin Water Well Drillers.
  - Brian Strebe Lakeshore College in Cleveland.
  - Keith Karr Chippewa Valley Technical College in Eau Claire.
- Six hours built into this program provide the learner with experience in the SMAW process. One hour of the program will be dedicated to theory. The remaining five hours will be hands on welding activities. Welders will be given instruction on proper techniques used to produce quality welds. Welder's skill will be assessed while performing the necessary duties.
